NOTICE FOR PARENTS

Draw of Lots for Constitution of School Level Fee Regulation Committee (SLFRC)

Date: 02.09.2026

The Directorate of Education had in December 2025 proposed certain guidelines for fixation of school fees. The Act & Rules were subsequently challenged and the matter is still sub-judice. Nonetheless, this is to inform all Parents & Teachers that a draw of lots shall be conducted in the school premises on Thursday, September 10, 2026 for the selection of Parent and Teacher Representatives to the School Level Fee Regulation Committee (SLFRC).

Purpose of the Draw: The draw of lots is being conducted for the constitution of the SLFRC, to examine and decide matters relating to fixation and regulation of school fees.

Categories for Selection:

- Five (5) Parent Representatives
 - Three (3) Teacher Representatives

- The selection shall be made through a transparent draw of lots, along with preparation of a waiting list (10 parents and 06 teachers or more), strictly as per the Rules.
 - An unwilling parent whose name is drawn shall be required to submit an "Unwillingness Application" to the Directorate of Education (DoE) through the school.

Eligibility

- All parents/guardians of students presently on the rolls of the school and all regular teachers of the school shall be eligible and shall be included in the draw of lots.

- Parents/guardians of students admitted under the EWS/DG/CWSN categories, who are exempted from payment of fees, shall not be eligible for selection as Parent Representatives.

Time: 2:00 P.M.

Venue: Salwan Public School, Rajendra Nagar

Observer: Shri Brahmjeet Singh & Vikash Kulshrestha, DoE Nominees from Department of Education.

The draw shall be conducted by the school management in the presence of the Observer of DoE. No one is permitted to influence or interfere with the process in any manner. The proceedings shall be video-recorded.

Final List: –The Final selected names, who will constitute the SLFRC, will be declared as per Rules. The subsequent meetings of SLFRC as required will be intimated from time to time.

- a. Certain **facilities**, round the year, **are being provided to students** and consequent to the National Education Policy 2020, additional facilities and corresponding infrastructure is be catered to in addition to deployment of additional staff. The school shall not compromise on these aspects as well as remittance of statutory payments to be made as a sequel to the recommendations of the 7th Central Pay Commission, the New Labour Code, and such other statutory enactments issued by the Government from time to time. Hence, the selected parents will be responsible for factoring all these aspects to **Fee Proposals to be decided**. A pragmatic approach by parents to avoid accumulation of their liability will be in the best interest of the Students as well as the Institution.
- b. *This process of constitution of SLFRC, as per the order received, does not in any way preclude the school from exercising its legal right to seek amendments at any time in the future, nor does it restrict the school from availing any other legal remedies, as may be required.*
